His last assignment was as Director for Innovative and Sustainable Mobility within the Directorate-General for Mobility and Transport. Brian Simpson was first elected to the European Parliament in June 1989. Representing the North West of England, Brian is recognised in the parliament for his work on transport and tourism. He has been a member of the Transport & Tourism Committee since becoming an MEP and is currently one of its longest serving members. From 1991 to 2004, he held the position of Socialist Group spokesperson for Transport & Tourism. He was re-elected to this position in 2008. In 2009 he was appointed the chairperson of the Transport and Tourism Committee. From 1st July 2014 he will take up the position of TEN-T Co-ordinator for Motorways of the Seas.

He is also a member of the Agriculture and Rural Affairs Committee where he acts as the British Labour Party spokesperson. He has held other positions within the European Parliament including, the Presidency of the Parliamentary Delegation for relations with Norway, Iceland and Switzerland and Vice President for the delegation with the former Yugoslavia. He is presently an active member of the Parliament's delegation for relations with Australia and New Zealand.

His hobbies include most sports (particularly rugby league), Heritage Railways and Military History. Brian is particularly well read on the American Civil War and is a keen member of the Civil War Trust. He is Vice President of the Heritage Railways Association.

President of ERFA

On 20th January 2011, Mr François Coart was elected President of the European Rail Freight Association (ERFA). As from 06/2012, he is Development Director of Europorte. From 09/2010 to 06/2012, he is Strategy Director of Europorte (F&UK), the one of first privately owned rail freight operator in Europe. Europorte is the railway undertaking of the Groupe Eurotunnel. Since 2008, he is also General Director of the Groupe Eurotunnel subsidiary London Carex (UK), dedicated to develop a high speed rail freight terminal in London. During 2009 and 2010, he was also leading the acquisition of the 3rd largest rail freight operator in the UK, GB Rail Freight and of the French assets of Veolia Cargo for his group. In 2006 he joined Groupe Eurotunnel as Rail Development Director. From 1993-2003, he was working with Alstom Transport (F), amongst others as Vice-President Commercial & Marketing France. From 1989-1993, he was working with Bombardier (B), amongst others as Marketing Manager. Mr François Coart is a commercial engineer (Catholic University of Louvain, B).
